

An Ordinance to designate an enforcing agency to discharge the responsibilities of the Township of Backus under the provisions of the State Construction Code Act (Act 230, P.A. of 1972).

The Township of Backus ordains:

Sec. 1. Agency Designated. Pursuant to the provisions of the Michigan Plumbing Code which consists of the BOCA Basic Plumbing Code, 1970 edition, including accumulative supplement dated 1973, except sections P-102.0, P105.0, P-302, P-501.2, P-1101.5, P-1205.2, P-1500.0 through P-1511.4, and P-1700.0 through P-1705.2 which have been deleted and includes amendments to P-100.2, P-117.0, P-201.1, P-301.2, P-301.1, P-308.2, P-313.3, P-405.12, P-602.31, P-701.16, P-701.2, P1001.7, P-1101.3, P-1101.4, P-1102.0, P1204.55, P-1605.10, P-1606.21, P-1606.22, P-1606.23, and further includes additions being: R 408.30725 (P-309.3,), R 408.30752 (P-1001.9), R 408.30762 (p-1205.41), R 408.30791, R 408.30792, R 408.30793, R 408.30795 and R 408.30796, of Act 230 of the Public Acts of 1972, the plumbing official of the Township of Backus is hereby designated as the enforcing agency to discharge the responsibilities of the township of Backus under Act 230 of the Public Acts of 1972, State of Michigan. The Township of Backus hereby assumes responsibility for the administration and enforcement of said Act throughout its corporate limits.

Sec. 2. All Ordinances inconsistent with the provisions of this Ordinance are hereby repealed.

Sec. 3. This Ordinance shall be effective after legal publication and in accordance with provisions of the Act governing same.
